
Introduction

Reimbursement Modifications


- Supports adding new reporting categories to track new funding sources for new programs such as Extended Foster Care
- Allows multiple reporting categories for a service to allocate a payment across multiple funding sources
- Provides the ability to inactivate a service type
- Improves service type age range functionality




Scenario 1 CPA (Child Placing Agency) Group Home

Topic 1: Report Categories and Other Cost Accumulators (OCAs)

The ability to maintain reporting categories online within FSFN supports changes to funding sources. For example, the new funding sources for Extended Foster Care can now be added by a state level fiscal administrator using this new functionality.



Enhancements: Report Categories

- New Reporting Category Page provides a state fiscal administrator with the ability to view reporting categories, and access the Other Cost Accumulator page to create and maintain reporting categories and associated OCAs
- Fiscal Workers and Supervisors access the new Reporting Category page to view the reporting categories and access the Other Cost Accumulator page to view associated OCAs
- All active reporting categories are listed by default, with the ability to filter by inactive reporting categories



Enhancements: Other Cost Accumulator

- Existing page modified to create and maintain reporting categories along with their associated Other Cost Accumulator values (OCAs)
- Access changed from the new Reporting Category page
- State level fiscal administrators create new reporting categories using the Copy hyperlink or Insert button on the Reporting Category page, and entering title, effective date, and associated OCAs
- State level fiscal administrators edit an existing reporting category using the Edit hyperlink on the Reporting Category page to update the title, effective/inactive dates and update the associated OCAs. Note: When inactivating a reporting category that has active service types, the user receives an informational message so they can coordinate with the Fiscal Agencies who are using the reporting category for their service type.
- Fiscal Workers and Supervisors have view access to this page via the Reporting Category page and the Service Type page

Topic 2: Service Type Maintenance

Service type modifications provide the ability to better manage services in FSFN and support changes to funding sources. It also provides the capability to specify a single service that uses multiple funding sources, as long as it is for the same child and provider. Finally, age is modified to from/through age to better manage services that are based on age.



Enhancements: List Service Types

- This new page provides a list of service types and the ability to create a new service type by copying an existing service type. This includes filter criteria for service category, service type, reporting category, active/inactive and placement/service.
- Users access this page from the Financial Work page, Utilities drop down and List Service Types.
- This page remains open when launching the Service Type page from this page.



Enhancements: Service Type

- Access is added via the new List Service Types page. The existing access via Financial Work page is preserved.
- Service types have new effective and inactive dates that ensure that new placements and services cannot be created after the inactive date. Any existing placements and services will remain open and continue payments until they are ended or age out.
- Age is now two fields, Age From and Age To (Through).
 Birthday batch uses age to either create the next service
 when a next service is defined, or to end the service
 automatically if there is not a next service.
- Service rate is moved to the Service Type page along with a new group box for defining multiple reporting categories for the rate when the rate is by service.



Enhancement: Provider Service Rate

- Multiple rate categories are added to this page for defining multiple rates when the rate is by provider
- Service types with an inactive date will be filtered out based on the date the provider is approved so they are not used going forward

Topic 3: Multiple Rates for a Service or Placement

Placement and Services now prevent the use of an inactive service type and support multiple reporting categories.



Enhancements: Out of Home Placement

- Service type effective/inactive dates are used to prevent selection of a service type that is inactive before the service begin date
- For a service type associated with multiple reporting categories and a child specific rate, the user is prompted to allocate the child specific rate among multiple reporting categories
- Rate settings are now viewable on the Financial tab
- The page layout now uses the new Action and Text panels instead of the Options drop down



Enhancements: Service Financial Tab

- Service type effective/inactive dates are used to prevent selection of a service type that is inactive before the service begin date
- For a service type associated with multiple reporting categories and a child specific rate, the user is prompted to allocate the child specific rate among multiple reporting categories



Enhancements: Payment Request Page

- Service type effective/inactive dates are used to prevent selection of a service type that is inactive before the service begin date
- Ongoing service types included in addition to the existing one-time service types

Topic 4: OCA Reports and Check Write File

- OCA Reports allocate a payment among multiple reporting categories and their associated OCA(s), and a unique identifier for the OCA entry
- OCA Reports include Service Through Date as a new parameter to filter out invoices already released for the next service period from the current month's OCA Report
- Check Write file also allocates payments among multiple reporting categories, along with a unique identifier for the OCA entry. Additional columns needed for the Q3 release are included in the file layout to mitigate the need to make coding changes again due to layout changes
- Note: payment does not appear as multiple entries on the Pending Invoice since OCAs are not part of that report






